Definitions	
Everyday Business Purposes	The actions necessary by financial companies to run their business and manage customer accounts, such as providing investment advisory and financial planning advice, processing securities transactions, and otherwise providing financial services to you.
Affiliates	<p>Companies related by common ownership or control. They can be financial and non-financial companies. Mosaic Wealth has the following affiliates:</p> <p>Focus Financial Partners, LLC Focus Risk Solutions SCS Capital Management LLC Sentinel Benefits Group, LLC</p>

Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. Mosaic Wealth does not share information with non-affiliates for marketing purposes.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Mosaic Wealth does not engage in joint marketing with non-affiliates.
